She has advised public and private companies on a variety of transactions, including initial and secondary public offerings, mergers and acquisitions, foreign direct investments into mainland China, private equity transactions, joint ventures as well as general corporate advisory work for listed companies. She has also worked for two international law firms, namely Linklaters and Morrison & Foerster.

Ms. Maurellet joined HSH in 2006 as Legal Counsel and in 2009 she was promoted to be Senior Legal Counsel. To deepen her knowledge of the hospitality industry, she completed a Master Certificate in Essentials of Hospitality Management from the Cornell University School of Hotel Administration in 2008.
